Plantation Estates Future Projects and Goals:

What are we planning for this new fiscal year? We have compiled a list of potential projects for the neighborhood. We have included areas where we want to make some improvements in how we operate the association.

- 1. Be more aggressive about keeping the brick wall along Barataria Blvd. clean and keeping the sidewalk trimmed and grass cut regularly.
- 2. Organize a volunteer effort to clean up and beautify the median on Oak Alley Blvd. after the Parish completes their tree removal work.
- 3. Perform additional tree trimming and fertilizing of our existing oak trees along Oak Allev Blvd.
- 4. Replace the crape myrtle in our front flowerbed that fell over during Hurricane Ivan.
- 5. Re-stain the background and paint the PE sign at our main entrance. Install a new Plantation Estates sign at our Parlange Drive entrance.
- 6. Solicit proposals from local termite companies about installing a termite bait system around the oak trees on Oak Alley Blvd.
- 7. Solicit proposals for the installation of a decorative yet functional message board at the Barataria Blvd. entrance. We have a couple signboards in mind and will make a proposal to the PECA BOD later this year. Also, look into a voice mail system to further enhance communication to our homeowners.
- 8. Continue to work with Jefferson Parish Traffic Engineering officials on finding solutions to traffic concerns at the intersection of Gainswood Drive East and Parlange Drive. We will keep you posted.

What are we doing to make Plantation Estates a special place to live?

- ✓ Continue to provide enhanced security to our homeowners with average daily JPSO detail coverage of 10 to 12 hours per day.
- ✓ Continue with our seasonal programs such as the holiday banner program, Christmas lights display, Santa Claus visit and Easter Egg Hunt for the kids and the holiday home decorations awards.
- ✓ Continue efforts to maintain attractive flowerbeds at our 2 main entrances.
- ✓ Continue the very successful Garden of the Month awards program.
- ✓ Continue to develop and foster projects like the main entrance flag pole project.
- ✓ Continue to hold 2 homeowner's meetings per year that are interesting and informative.
- ✓ Continue to provide a quarterly newsletter and maintain our website.
- ✓ Continue to make sure we welcome new homeowners to the neighborhood.
- ✓ Continue our aggressive efforts on resolving restriction problems in the neighborhood.
- ✓ Continue to have representatives from the association serving on the West Jefferson Civic Coalition and the Jefferson Envision 2020 Plan
- ✓ Continue to foster relationships with the elected governmental officials on matters that impact the neighborhood and the Westbank.
- ✓ Keep the channels of communication open, listen to your concerns and solicit your input on neighborhood matters and issues.

President's Report-

Dear Friends and Neighbors:

We were blessed this summer season when Hurricane Ivan stayed east of the metro area, sparing us the catastrophic destruction that occurred along the Alabama and Florida Gulf coast. Our thoughts and prayers go out to all those people who did suffer property damage and loss of life during this storm. Many of us did evacuate that Tuesday and Wednesday and were caught in traffic jams going in all directions. Hopefully our elected officials from all over the area will work together and come up with a workable solution to our evacuation problems. We had numerous trees along the Oak Alley Blvd median that due to age, disease and insects had become a legitimate safety concern in the high steady winds of a hurricane. We want to say thank you to our Jefferson Parish officials for recently removing those trees, hopefully alleviating future potential problems. We did lose one crape myrtle tree at the main entrance to the subdivision during the storm and we will allocate funds to replace that tree.

On September 18 the voters in Louisiana went to cast their votes for Constitutional Amendment No. 1. The amendment passed overwhelmingly and we have included the Precinct 204 results later in the newsletter.

The Plantation Estates Board of Directors held its quarterly board meeting on September 7 at the Marrero Estelle Firehouse. The following topics were covered:

- Plans were made for the upcoming PECA dues renewal period.
- Halloween security plans were discussed, including the results of our survey of homeowner's on Halloween security and traffic concerns. Results were mixed with the general consensus being to increase the visible presence of our JPSO patrols and to ask all residents not hosting a party to turn out their lights by 9:00 pm to discourage late evening problems. Colonel John Fortunato of the Jefferson Parish Sheriff's Office has a separate article on Halloween security plans.

- Funds were allocated for preliminary planning on a Pumpkin Painting Party in October for the neighborhood kids.
- The board voted to continue our landscape contract for the next fiscal year with Patio Gardens at the current monthly rate.
- We had a request from several homeowners' about installing a gate at the end of Oakley Drive. The gate would allow those students attending St. John Bosco Middle School a path to walk to school. We ran a homeowner's survey for 2½ months and received 50 responses over that time period. All responses were absolutely against the installation of the gate for security concerns. The board considered the responses in the surveys and voted to decline the request to install the gate.

In closing I want to say thank you to all of the volunteers that helped in our Barataria Blvd. brick wall-cleaning project. The project included pressure washing the wall, mowing and trimming the grassy area. These guys worked very hard and everyone should be thankful that we have people like them. To all of the homeowner's on Anchorage that allowed us to use their water, thank you. Finally, Norman Gauthreaux who headed up our flagpole committee did a first class job in arranging the installation of a flagpole with lights at our main entrance. The flagpole really adds to the look of the entrance and should make everyone proud.

Thank you again for your past support and I hope you continue to support your homeowner's association during this renewal period.

































Restrictions Committee Report By Candy Jensen

Constitutional Amendment No. 1

On September 18, 2004 the voters of Louisiana went to the poles to cast their votes on Constitutional Amendment No. 1. The amendment will ban same-sex marriages and civil unions and prohibit state judges and other officials from recognizing same sex unions performed by other states. Turnout for the election was low at 16.72% in Jefferson Parish. Approximately 46,758 of the 279,600 registered voters turned out to cast their votes. Our precinct, 204, faired slightly better with 20.96% voting or 227 out of 1083 registered voters. The results for precinct 204 were as follows:


November 2 Elections

First of all, for those of you who haven't been able to attend our PECA general membership meetings, we provide an up to date crime map of the entire Plantations Estates subdivision. Go on and take a look. You may find it useful. This is a backyard set in which the data is automatically transferred to a computer. The computer uploads the information to the weather web site.

Flag Committee Report

By now everyone should be aware that our flagpole project at the Oak Alley Blvd entrance is complete. The process of securing bids, approval of funding, obtaining permits, and finally actual construction has been an almost two year endeavor, but one I'm sure you will agree was well worth the wait. Since the pole and flags have been up, several residents have inquired about the smaller black and white flag displayed under 'Old Glory.' Therefore I thought that it might be appropriate to write a short history of this flag as well as touch on proper flag etiquette for the U.S. flag since some of you may not be familiar with certain procedures.

Flag etiquette is contained in the U.S. Flag Code, which was adopted in 1924, passed into law in 1942, and amended in 1976. While a comprehensive list of the regulations and procedures contained in this code is much too long for this newsletter, anyone interested in further details may find the websites www.niceflag.com/etiquett.htm and www.suvcw.org/flag.htmvery informative.

One method of display which many people get incorrect is hanging the flag vertically. When the U.S. flag is displayed vertically, the union (blue field with stars) should be uppermost and to the observer's left (the flag's right). So when you see our flags on the light poles during the summer months, although it may look strange to some residents, be assured that they are being displayed properly.

I would also like to call your attention to the days when you will see our flag flying at half-staff. There are five official days during each year that the U.S flag has been designated by the code to fly at half-staff. Those days are as follows:

- 1) Peace Officers Memorial Day May 15
- 2) Memorial Day Last Monday in May (half staff until noon only)
- 3) Korean War Veterans Dav July 27
- 4) Patriot Day September 11
- 5) Pearl Harbor Remembrance Day December 7

So remember, when you see the flag lowered on the above days it is intentional. At any other time the flag may be at half-staff by direction of the Congress or President, such as the death of a former president.

The smaller flag you see displayed below the U.S. flag has an interesting history. This is the POW/MIA (Prisoners of War/Missing In Action) flag. In 1971 Mrs. Michael Hoff, an MIA wife and member of the National League of Families, recognized the need for a symbol to represent our nation's concern and commitment to resolving as fully as possible the fates of Americans still held as prisoners or missing and unaccounted for in Southeast Asia. She approached Flag Company vice president Norman Rivkees to design a banner for this purpose. The company had an employee at the time, former WWII pilot Newt Heisley, who embraced the idea and came up with the design. It consists of the silhouette of an American POW with a prison tower and barbed wire in the background, POW MIA in bold letters, and the words 'You are not forgotten

As a result of the persistence of Mrs. Hoff and the National League of Families, on August 10, 1990, the 101st Congress passed U.S. Public Law 101-355, which designated Mr. Heisley's design as the official symbol of our concern for this cause. While it was originally intended to raise awareness for Vietnam POW/ MIAs, it has now come to symbolize the unaccounted for in all previous and

The POW/MIA flag is the only other flag besides the Stars and Stripes to fly over the White House and the only flag that is displayed inside the U.S. Capitol Rotunda. It must also by law be flown over all military installations, federal cemeteries, and all offices of the U.S. Postal Service.

So when you see the flag displayed in various locations as you travel, remember that it stands for the plight of those Americans who have sacrificed their own freedom to preserve liberty for all of us.

It has been my pleasure and honor to serve as chairman of the flagpole committee. At the last board meeting, I also volunteered to maintain and monitor the flags as necessary during the year. If anyone observes any problems with the flags or pole, please do not hesitate to contact Jim Brilli or me for resolution.
